### **Corporate Member Obligations**

**Club Financial Obligations:** Applicant understands that the current Southern Pines Rotary Club quarterly dues are \$47.00. Corporate Meals are currently \$18.00 per week. Make-ups at other clubs will be credited against meal charges. Membership dues include an annual subscription to the official Rotary International magazine. Dues and meal charges will be billed quarterly. A one-time materials fee will be assessed on the first bill (\$50.00 for Executive and \$25.00 for each Associate).

NOTE regarding Meal Charges: If two or more corporate members attend the same meeting, the Corporation will be invoiced \$15.00 for each additional meal. Club bills will be addressed to the Corporate Executive Member and shall be the responsibility of the Executive Member and not the responsibility of the Associates. Payments shall be made to the club (SPRC) and are due within 30 days from billing or as otherwise noted on the invoice.

**The Rotary Foundation Obligations:** One becomes a Paul Harris Fellow after s/he has contributed \$1,000 to the Foundation. If the proposed Executive member is not a Paul Harris Fellow, the Corporation's first bill will include a \$100 Paul Harris Sustaining membership fee, and the Corporation agrees to pay an assessment of \$25.00 per quarter to remain a sustaining member. The Rotary Foundation is an IRS 501 (c) (3) organization and contributions are tax deductible. The Southern Pines Rotary Club is a 100% Rotary Foundation Sustaining Club which means that all members are expected to contribute at least \$100 annually to the Rotary International Foundation.

NOTE: Foundations

- The Rotary Foundation: All designees are encouraged to give to the TRF in their own name of at least \$100.00 annually. Associates are encouraged, but are not required to donate.
- SPRC Charitable Foundation: All designees are encouraged to give to the club's local charity foundation, but it is optional.

**Attendance Obligations:** 50% attendance is required by Rotary International. Attendance by both the Executive and Associate member(s) will be counted toward the 50% attendance figure. More details will be given at Orientation regarding make-ups and service projects.

**Fundraiser Participation:** A Corporate Member's designees shall be considered as one member for fundraiser participation requirements, including attendance and sales participation.

**Club Participation:** All Corporate Members, (Executive and Associates), are eligible to serve on Club committees and on the Board. However, only the Executive Designee is eligible to serve as a Club Officer. Other designees are encouraged to pursue a personal membership if they desire to serve as a Club Officer. A Corporate Member may have one vote for Club elections and voting.

**Corporate Membership Induction:** All designees (Executive and Associates) will be required to attend an informational meeting about the Rotary Club of Southern Pines and Rotary International prior to the Corporate Members being inducted but after being approved by the Board and the membership.

**NOTE: CORPORATE MEMBERSHIPS ARE A THREE-YEAR PILOT PROGRAM. At the discretion of the Board of Directors, the Pilot Program may be discontinued.**

Options: Executive member remains as a regular member.

Associate becomes a regular member.
