## Member Obligations

**Club Financial Obligations:** Applicant understands that the current Southern Pines Rotary Club quarterly dues are \$49.00. Meals are currently \$17.00 each. (Active Members will be billed for 10 meals each quarter. Socials will be billed separately.) Make-ups at other Rotary Clubs at which you pay for a meal will be credited against meal charges. Membership dues include an annual subscription to the official Rotary International magazine (you may request to receive a digital copy). Dues and meal charges will be billed quarterly. A one-time materials charge of \$40.00 will be assessed on the first bill.

**The Rotary Foundation Obligations:** A Rotarian becomes a Paul Harris Fellow after contributing \$1,000 to The Rotary Foundation (TRF). The Southern Pines Club has committed to be a Paul Harris Sustaining Club which means that all members are expected to contribute at least \$100 annually to The Rotary Foundation. If the applicant is not a Paul Harris Fellow, the first bill will include a \$100 contribution to The Rotary Foundation, and the applicant agrees to pay an additional quarterly contribution of \$25.00 per quarter to remain a sustaining member. When a total of \$500.00 has been contributed, the Club agrees to match the contribution with Club points enabling the member to become a Paul Harris Fellow. The Rotary Foundation is an IRS 501(c)(3) organization and contributions are tax deductible.

**The Southern Pines Rotary Charitable Foundation:** The SPRC Charitable Foundation is a separate 501(c)(3) organization owned by the Club to fulfill its local charitable purposes. All members are encouraged, but not required, to contribute to the club's foundation. Cumulative Contributions in excess of \$500 earns recognition as a Samuels – Capel Fellow. Contributions may be optionally billed on your quarterly statement.

**Attendance Obligations:** To remain an active club member, regardless of membership classification, the member must “meet” at least twice a month. e.g. completing service projects, attending networking events, social activities, online/virtual meetings, attending a committee meeting, Board meeting, or Charitable Foundation meeting...ALL count as a “Participation Meeting.” We ask that you inform the Club Administrator of these meetings to receive attendance and participation credit. (Meal credits are NOT given for participation “meetings.”)
